

# Creating scholarships is EASY!

## 1. Determine the dollar amount.

For individuals taking the Arizona Tax Credit the maximum amounts are listed on the participation form. For individuals not taking the Arizona Tax Credit, these maximums do not apply.

## 2. Determine if you would like to recommend a child or school.

Although Arizona law prevents us from using the recommendation as the only consideration when awarding scholarships, we do use it as one of the primary considerations.

## 3. Make your donation.

## 4. Take the credit.

Take your donation as a dollar-for-dollar tax credit on your Arizona state taxes and check to see if it can be a deduction off of your Federal taxes too.

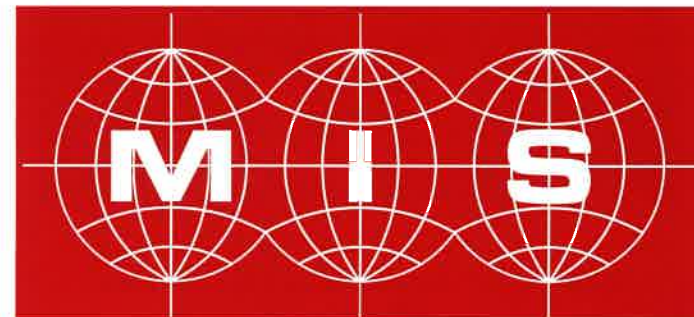
